

**Procedure to Control the Use of Conformity Certificate / License and Conformity Mark / Logo****1. Purpose and Scope:**

This procedure aims to describe the steps adopted by RACS Quality to control / regulate the use of conformity license / certificates and conformity mark / logo issued to certified clients.

**2. Responsibilities:**

It is the responsibility of the Management Representative or his delegate to:

- Approve and maintain the steps taken for the control of use the license, certificate, and conformity Mark / logo.
- Ensure the communication of policy and procedures related to best practices in each department.
- Continuous review and updates for the related procedures.

**4. Applicable Conformity Marks / Logo:**

As detailed in RACS Quality manual, for various scopes RACS acts as an independent third-party certification body (Issuing RACS Certificates). In addition, it acts as notified body for Ministry of Industry and Advanced Technology (MOIAT) to issue Emirates Scheme for Certificate of Conformity (ECAS) and Emirates Quality Mark (EQM), as notified body for GCC Standardization Organization (GSO) to issue G-Mark, as notified body and/or third party conformity assessment body authorized by Saudi Standards, Metrology & Quality Organization (SASO) to issue SASO / SABER - Certificate of Conformity and Saudi Quality Mark, as accredited body by GCC Accreditation Center (GAC), as accredited body by Ministry of Industry and Advanced Technology - Emirates National Accreditation System (MOIAT-ENAS) and as accredited body by Emirates International Accreditation Centre (EIAC).

The term symbol or mark here is used as synonymy.

- RACS owns its Certification Mark of Conformity as part of its Certification system, along with RACS QUALITY final Product (the certificate), and applicable scheme owner certification scheme. Once certified by RACS, the client has the right to use RACS Mark of Conformity. A client using RACS Mark of conformity shall fully comply with requirements for the use of 3rd party marks available in ISO/IEC 17030.
- For Conformity Marks / logos belonging to Scheme owners (MOIAT, SASO & GSO), the same rules and obligations and restrictions detailed in this procedure along with requirements of applicable scheme owner requirements for use of conformity mark / logo. Those marks are not RACS Property obviously, rather it is the scheme owner property, however RACS has the right to grant those marks to client in accordance with the authorization of the scheme owners to RACS to be notified body and recognized 3rd party CAB. Once certified, the client has the right to use those Marks of Conformity and shall fully comply with requirements for the use of 3rd party marks available in ISO/IEC 17030 and applicable scheme.
- As per MOIAT's (Scheme Owner) Usage Policy, after obtaining the Certificate of Conformity (CoC), the licensee shall use the ECAS / EQM Mark of Conformity on the certified products as per applicable scheme requirements.

**Procedure to Control the Use of Conformity Certificate / License and Conformity Mark / Logo**

- Control the use of RACS conformity certificates & marks and scheme owner's conformity certificates & marks of conformity by its clients by following ISO / IEC 17030; methods and procedures are documented and communicated to client through this Procedure.
- RACS Quality makes it clear to its clients that it owns exclusively its Certification Mark of Conformity as part of its certification system, along with RACS certificate, and its certification scheme and the right to use RACS Mark of Conformity is authorized only to the certified clients who signed the certification agreement and are approved for certification.
- RACS Quality Certification Mark is granted to Products or services meeting the applicable standards or requirements. It should be very clear that the certification mark will be used exclusively on certified products, so no confusion should happen between certified and non-certified products. Furthermore, usage of certification mark should be handled with extra care and attention.
- RACS Quality assures the controlled and accurate usage of all conformity certificates and conformity mark / logo by continuous monitoring and ongoing auditing, especially during 1st and 2nd year annual surveillance and re-certification audit, besides market monitoring, in a way that if any Intentional misuse of the conformity mark / log happen by client necessary corrective actions will be taken on immediate basis.
- A client using RACS Quality Mark of conformity shall fully comply with requirements for the use of 3rd party marks available in ISO/IEC 17030.
- RACS Quality entitles its client to use Conformity Mark on products covered by the appended license, as approved by RACS for such products in accordance with the applicable standard / scheme.
- The stipulations of the general rules for the applicable certification scheme and all applicable related standards shall apply to the use of Certification Mark.
- Once Certified, RACS Quality agrees that the related certified Facilities and products manufactured comply with the requirements of applicable standards specified in the license. Accordingly, it is a recognition and authorization for the applicant to mark the products covered by the license using RACS Quality Certification Mark
- It is the applicant responsibility to assure that for every and each time the products (for which the license is granted) are available, they should be produced within the same specifications and quality similar to the conditions and samples tested by RACS Quality and found to be in conformity with applicable standards.
- Printing of certification mark shall be performed within exactly the same presentation listed below (size, colors & dimensions), using materials assuring the accurate and sharp production of the mark.
- To ensure the above is met, upon approval for certification and prior to issuance of certificate, the certification Mark is handed over to client in a Soft Copy format.
- Upon signing this certification agreement, applicant declares of fully understanding the requirements, terms and conditions, usage policy of safeguarding RACS Quality Certification Mark and commit to fully comply with them and not to make any statement or act in any way that may be considered misleading. Furthermore, the applicant agrees and recognizes the use of its certification mark upon certification approval decision.
- Promotional and marketing purposes (either constant: brochures, letterheads, flyers, website, etc., or variant events: exhibition, etc. using RACS Quality Certification Mark are accepted by RACS Quality with no objection under the condition of providing the certificate not along with the certification mark in case of such activities. This use shall be done within the accepted conditions mentioned above, such advertisements can be placed on display panel of the certified products, on the secondary or packaging, on company publicity materials such as brochures, company profiles, reports, exhibition materials, flyers, banners, roll-ups etc.
- On corporate electronic media such as websites, internet, on the internal walls and doors of the factory/offices, on company vehicles, on company communication documents such as letterheads, stationery etc.
- RACS will conduct continuous monitoring of certified products to ensure correct use of its Certification Mark.
- Instructions or another user information accompanying the product and related to the certification scheme

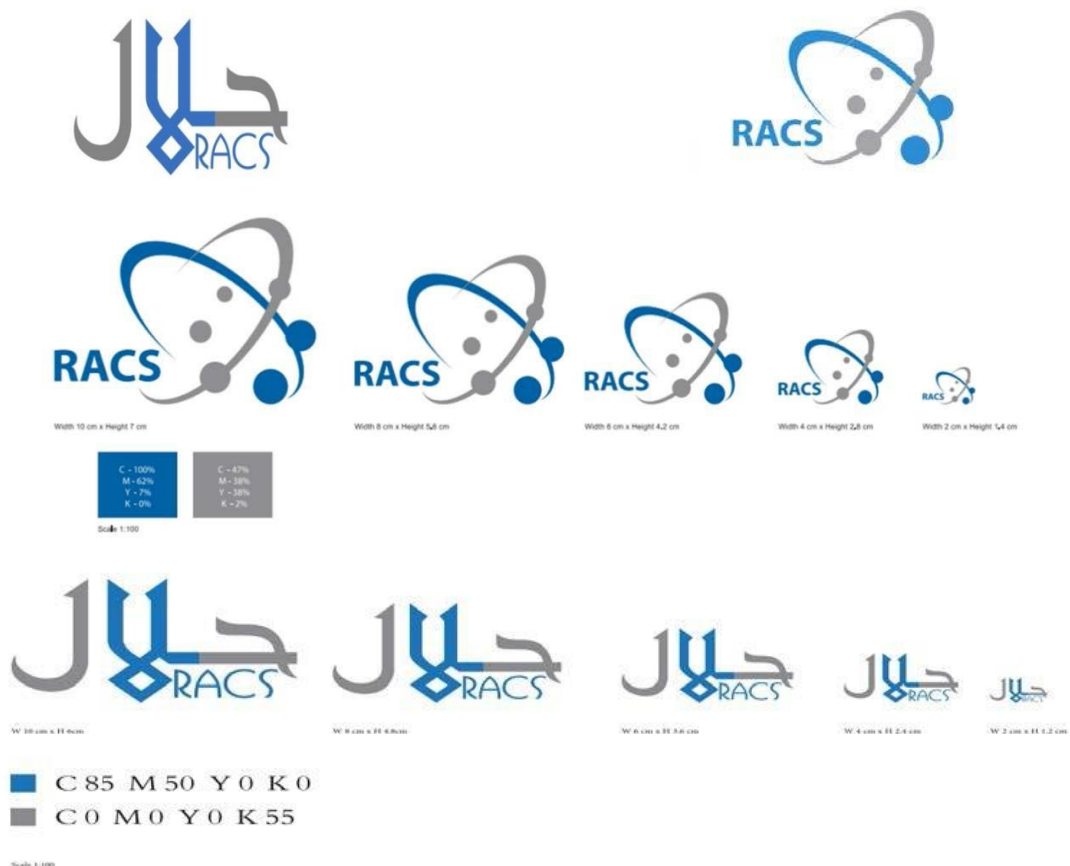
- In case of any doubts regarding the use of the logo, prior written approval shall be granted by RACS Quality to prevent misuse and subsequent corrective action.

### 6. Procedures for Use of Accreditation Marks:

- Any certified client of RACS Quality is not allowed to use the EIAC / ENAS / GAC's accreditation mark / logo on a product or product packaging seen by the consumer or in any other way that may be interpreted as denoting product conformity.
- RACS is committed that EIAC/ENAS/GAC accreditation or accreditation symbol is not used in a way which will not misrepresent the accreditation status or bring the accreditation process into disrepute.
- EIAC/ENAS/GAC accreditation mark/logo will be used as per defined the defined policies of the accreditation body.

  - The size of the logo shall be in the following ratio and of size variations (decreasing or increasing) mentioned below.
